



INTEREST RATE INFORMATION

VARIABLE

The interest rate on a securities-backed line of credit may vary based on the maximum drawing power of the loan (commitment amount) at the time of application, and is calculated using the sum of the Wall Street Journal Prime Rate (WSJP) and the margin shown here. Changes to the Total Commitment Amount of the loan may result in a change to the interest rate.¹

THREE-YEAR FIXED

There is also a fixed interest rate option available for a securities-backed line of credit. Fixed rates are available for a three-year period; any loan balance remaining at the end of the three years will convert to a variable interest rate. Both new and existing borrowers² may take advantage of the fixed rates, which are detailed here. As with variable rate loans, the interest rate tier is determined by the maximum drawing power of the loan (commitment amount) at the time of application.

\$100k - 249,999.99	WSJP + 1.00%	None
\$250k – 499,999.99	WSJP + 0.75%	None

\$1MM+	WSJP + 0.50%*	None

PLEASE NOTE:

You have the ability to revolve your credit line, giving you the flexibility to draw and repay the line without early repayment penalties throughout the three-year period. There is no minimum draw amount and there is no time limit to make an initial draw on the line.
